A group of committed agriculturists have come forward with a mission to augment sustainable development of agriculture through establishment of high tech agro-industries. They have established a group of business companies named "Krishibid Group" (KG) with the founder firm - Krishibid Firm

Limited (KFL) being the holding company.

The group started operation in 2001 having registered with the Registrar of Joint Stock Companies and Firms. The business of the group began with a very small capital of only 30 thousand taka and a small poultry farm that accommodated only some 3 thousand poultry birds. Now, it is a well-known and famous organization having 33 sister concerns and many other organizations and projects, in which some 5000 employees are working. This is the only nation wide business organization among the agriculturist professionals in Bangladesh.

The KG has received a share money of Tk 2524 million from 6500 shareholders, against which an average dividend of 19% has been given since its inception. This is an unparalleled achievement. The shareholders have so far been paid back Tk 3158 million and their leftover share money is now Tk 2955 million. The group now possesses assets of Tk 30 thousand million which is about six times more than the liabilities. This has all become possible by the grace of Almighty, sincere and hard efforts of the management and maintenance of high standard business ethics.

KRISHIBID Firm Limited

The Krishibid Firm Limited (KFL), established in the year 2001, is the holding company of the KG. It is governed by a 9- Member Board of Directors. The policies and decisions taken by the Board are executed by an Executive Committee (EC) elected by the Directors.

The KFL has achieved ISO 9001:2015 Certification for its excellent corporate management and culture. KFL is a member of DCCI, APSA, Bangladesh Non Packer Frozen Foods Exporters Association & BSA.

The company has received share money of Tk 26.15 million from some 50 shareholders, against which an average dividend of 19% has been given during the past 20 years. The shareholders have been paid back Tk 53.69 million and their leftover share money up to June 2020 was Tk 75.70 million. The company's turnover was Tk 405.00 million during 2019-20.



GLORIOUS Lands and Developments Limited

The Glorious Lands and Development Limited (GLDL) was formed to help resolve the residential problems of the agriculturists and others. The GLDL has successfully developed large housing areas called **Krishibid City** at Birulia, Savar, Dhaka. The company possesses about 500 hectares of land having 3250 plots with provisions for all modern civic facilities.

The project area is on natural high lands and is uniquely protected from all pollutions. Permanent campuses of Glorious University (Proposed) and Glorious International School & College are within the project. The project has also kept provisions for hospital, mosque complex, park, shopping mall, graveyard, playground, etc.

The company has received share money of Tk 34.42 million from some 58 shareholders, against which an average dividend of 20% has been given during the past 16 years. The shareholders have been paid back Tk 52.29 million and their leftover share money is now Tk 80.96 million. The company's turnover was Tk 832.50 million during 2019-20.



KRISHIBID Poultry Limited

The Krishibid Poultry Limited (KPL) was established in 2005 for commercial production of chicken meats and eggs. The farm is Located at Guziam village of Bhaluka Upazila under Mymensingh. Two six-storied layer farms of the company accommodates about 1,50,000 birds having a daily production of about 1,00,000 eggs. The farm has a land area of 15 hectares with 30% water body. The poultry farm is isolated from human habitation. The KPL is a member of World Poultry Science Association and Bangladesh Poultry Industries Association.

The company has received share money of TK 50.37 million from some 53 shareholders, against which an average dividend of 19.8% has been given during the past 15 years. The shareholders have been paid back Tk 48.44 million and their leftover share money is now Tk 71.06 million. The company's turnover was Tk. 138.50 million during 2019-20.



KRISHIBID Properties Limited

The Krishibid Properties Limited (KPL) is engaged in building modern apartments and commercial spaces using best quality construction materials. So far, the KPL has completed and handed over 1,200 such apartments and around 1,300 apartments are underway for completion.

All the buildings of KPL are designed by highly qualified and experienced architects & engineers as per Bangladesh National Building code. The company has also purchased lands at Cox's Bazar and Kuakata for development of Holiday Suite and Five Star Hotel.

The company has received share money of Tk 39.17 million from some 61 shareholders, against which an average dividend of 19.8% has been given during the past 13 years. The shareholders have been paid back Tk 51.59 million and their leftover share money is now Tk 75.89 million. The company's turnover was Tk. 853.60 million during 2019-20.

Salt Limited

The Krishibid Salt Limited (KSL) is a concern of the KG that cultivates salt in an area of 400 hectares at Moheshkhali, Cox's Bazaar and also refines salts at Islampur for home and industrial consumption. The company has planned to establish an automatic salt industry in the salt industrial zone at Islampur to utilize its raw salt produced at Moheshkhali for manufacturing quality salt. The KSL is a member of Salt Mill Owner's Association.

The company has received share money of Tk 38.59 million from some 49 shareholders, against which an average dividend of 18.23% has been given during the past 12 years. The shareholders have been paid back Tk 42.78 million and their leftover share money is now Tk 62.57 million. The company's turnover was Tk 302.67 million during 2019-20.

Overseas Limited

A number of overseas countries consider Bangladesh as a major source of technical, skilled and unskilled manpower. The Glorious Overseas Limited is a company of KG that aims at developing human resources through specialized technical training in order to compete for overseas job opportunities. The company intends to provide honest, efficient and skilled manpower to the valued foreign employers for recruitment.

The company has received share money of Tk 28.28 million from some 37 shareholders, against which an average dividend of 18.23% has been given during the past 12 years. The shareholders have been paid back Tk 23.75 million and their leftover share money is now Tk 56.39 million.





KRISHIBID Feed Limited

An automatic feed mill has been set up to manufacture high quality poultry, cattle and fish feeds of all types with capacity of 20 tones per hour. It manufactures and markets high quality feeds. The mill is located at Nishinda Bazar of Bhaluka, Mymensingh.

The company guarantees supply of quality feeds to the farm owners. The Krishibid Feed Limited (KFL) is a member of Feed Industry Association of Bangladesh (FIAB). The company is under process of entering in to open Share Market as a Public Limited Company.

The company has received share money of Tk 186.02 million from some 134 shareholders, against which an average dividend of 17.41% has been given during the past 11 years. The shareholders have been paid back Tk 50.06 million and their leftover share money is now Tk 230.21 million. The company's turnover was Tk 1303.30 million during 2019-20.



KRISHIBID Farm Machineries and Automobiles Limited

The Krishibid Farm Machineries and Automobiles Limited (KFMAL) is a new company of the KG to import farm machineries and automobiles from India, Japan, China, Indonesia, Malaysia, Thailand and Korea for local sales. It has also plan to develop an assembly plant to assemble imported CKD vehicles. The KFMAL has been importing and marketing farm machineries suitable for local conditions with an aim to enhance agricultural mechanization and production in Bangladesh.

The company has received share money of Tk 39.24 million from some 59 shareholders, against which an average dividend of 12.66% has been given during the past 5 years. The shareholders have been paid back Tk 39.02 million and their leftover share money is now Tk 71.20 million. The company's turnover was Tk. 1250.00 million during 2019-20.





The Krishibid Fisheries Limited (KFL) is located at Bahadurpur, under Trishal Upazilla of Mymensingh district on 30 hectares of ponds and low lands. It has been breeding quality fish seeds and marketing them at both wholesale and retail markets. The company is planning to establish a National Brood Bank within the fish farm. The KFL is a member of Bangladesh Fish Hatchery & Culture Association and Bangladesh Fisheries Research Forum.

The company has received share money of Tk 54.08 million from some 54 shareholders, against which an average dividend of 17.41% has been given during the past 10 years. The shareholders have been paid back Tk 47.70 million and their leftover share money is now Tk 87.52 million. The company's turnover was Tk 270.00 million during 2019-20.



KRISHIBID Security and Services Limited

The Krishibid Security and Services Limited was established with a vow to provide lacuna free security and dedicated services as per requirement of our valued clients. The KSSL is uniquely organized and developed to offer customized security and services to meet the specific needs of clients. It provides smart and well trained guards and service personnel to ensure low-cost and high quality of security & services.

The company has received share money of Tk 31.19 million from some 36 shareholders, against which an average dividend of 17.41% has been given during the past 9 years. The shareholders have been paid back Tk 13.07 million and their leftover share money is now Tk 46.89 million. The company's turnover was Tk 832.00 million during 2019-20.



KRISHIBID Packaging Limited

The Krishibid Packaging Limited is a public limited company of Krishibid Group established in 2016 for fabrication and manufacture of plastic flexible packaging and foils for consumer industries. The industry is located at Birulia of Savar. The industry uses imported petroleum by-products e.g. PET, BOPP, MCP, MPET films, PE resins, industrial solvents, adhesives, etc. as raw materials. The main clients of the company's products are food industries, toiletries and soap industries, agro industries, pharmaceutical industries, etc.

The company has received share money of Tk 47.23 million from some 74 shareholders, against which an average dividend of 12.66% has been given during the past 5 years. The shareholders have been paid back Tk 27.69 million and their leftover share money is now Tk 85.84 million. The company's turnover was Tk 582.00 million during 2019-20.



KRISHIBID Bazaar Limited

The Krishibid Bazaar Limited (KBL) is a challenging addition in Krishibid Group, having a slogan “কৃষিবিদ পণ্য, পুষ্টিগুনে অনন্য” Community service is always a priority concern of Krishibid Bazaar which has the aim of serving the community by supplying safe, fresh and quality products at a comparatively low price. KBL was registered with the Joint Stock Company in the year 2012.

The KBL procures only brand products. Alongside the most competitive price, its fresh corner is unique with Krishibid Groups' own products. The fresh vegetables, fish, chicken and beef, other fresh products are sold which are free from all harmful chemicals.

The company has received share money of Tk 42.71 million from some 48 shareholders, against which an average dividend of 17.41% has been given during the past 9 years. The shareholders have been paid back Tk 29.12 million and their leftover share money is now Tk 61.98 million. The company's turnover was Tk 362.50 million during 2019-20.





KRISHIBID Printing & Publication Ltd.

The Krishibid Printing and Publication Limited (KPPL) has installed modern printing machineries. The mission of the company is to offer the best quality printing, packaging and publications services at competitive costs. The KPPL caters for high quality printing of books, journals, bulletins, periodicals, magazines, newspapers, catalogue, marketing and publicity materials, office materials etc. KPPL vows to serve each customer as if he/she is a member of the Krishibid family and of the Group.

The company has received share money of Tk 38.68 million from some 40 shareholders, against which an average dividend of 17.41% has been given during the past 9 years. The shareholders have been paid back Tk 32.26 million and their leftover share money is now Tk 57.71 million. The company's turnover was Tk 416.00 million during 2019-20.



KRISHIBID Tours & Travels Limited

The Krishibid Group has added a new fleet in its business named Krishibid Tours & Travels Limited (KTTL). The company having registered in 2012 facilitates tourism professionally. Visitors' comfort and security are the philosophies of this business venture.

The K TTL facilitates Hajj & Omrah packages, Airlines Ticket booking, Worldwide Hotel reservation, Inbound & Outbound tours, Visa processing, etc.

The company has received share money of Tk 29.15 million from some 48 shareholders, against which an average dividend of 17.41% has been given during the past 9 years. The shareholders have been paid back Tk 22.03 million and their leftover share money is now Tk 71.12 million.





This is a private limited company of Krishibid Group which was registered in 2016 with the Registrar of Joint Stock Companies and Firms. The filling station, located at Islampur in Cox's Bazar will sell all kinds of automobile fuels. Cox's Bazar is a very important place of tourist attraction. However, there are not enough filling stations for the vehicles to come to this city. It is therefore, necessary for public interests to establish more filling stations in the district. The Krishibid Food and Beverage Limited (KFBL) is a public limited company that was registered with the Registrar of Joint Stock Companies and Firms in 2016. The company has started to manufacture and distribute food and beverage products which are essential parts of society. However, in this age of pollution, safe foods and drinks are of utmost importance. Today, organic food items are of global concern. The KFBL is committed to manufacture and market safe and healthy food and drinks. It's vision is to become one of the largest food and beverage processing and manufacturing industries in the country.

The company has received share money of Tk 6.9 million from some 23 shareholders, against which an average dividend of 12.2% has been given during the past 5 years. The shareholders have been paid back Tk 0.62 and their leftover share money is now Tk 18.14 million The company's turnover was Tk 160.20 million during 2019-20.





The Krishibid Media Corporation Limited (KMCL) started its journey in 2016. This is a public limited company that envisages bringing about a revolutionary change in the development process of agricultural sector of Bangladesh through the use of information technology. The company runs an online television named "KTV Bangladesh" with a slogan of "Shobuz O Somriddhir Pothe". An online radio named "Voice of Bangladesh" (www.vob.fm), a media production house are also operated by the KMC. The KMC also publishes a monthly bulletin "Krishibarta" and an international standard scientific journal - "The Agriculturists", and a news paper - "The Daily Usharbani".



The Krishibid Seed Limited (KSL) imports, produces, processes and markets high quality seeds of cereals and other high value crops and assists farmers to enhance crop production. The KSL is a member of Asia Pacific Seed Association (APSA), Bangladesh Seed Association, Seed Industries Association in Bangladesh. A 30 bigha R & D farm with a tissue culture laboratory is devoted for crop variety development. The company envisions to augmenting the development of agriculture and farmers' livelihoods in Bangladesh through production and supply of high quality seeds.

The company has received share money of Tk 41.50 million from some 47 shareholders, against which an average dividend of 12.66% has been given during the past 5 years. The shareholders have been paid back Tk 13.23 million and their leftover share money is now Tk 49.59 million. The company's turnover was Tk 327.50 million during 2019-20.



The Krishibid Trading Limited (KTL) is a new company under KG, which has been registered with the Registrar of Joint Stock Companies and Firms in the year 2017. Bangladesh has to import a huge quantity of consumer goods like Pulses, Chickpea, Spices, Onion, Garlic, Food Grains, fertilizers, ingredients for animal feed manufacture industries, and other industrial raw materials. The KG has taken a timely initiative to establish a trading company to import those materials.

The KTL ensures that the all the imported products are of high quality and the feeds manufactured out of these are health and environmental friendly. In near future, the KTL will import consumer goods maintaining high quality as per international standard. The KTL envisions to become one of the largest importers of consumer goods as well as industrial raw materials in Bangladesh.



The KGeCom Limited is a 'private limited' company established in 2019 under Krishibid Group with a vision to drive a new era of development, growth and productivity. It is working for societal and organizational development, capacity building and resource optimization through technology initiatives. Technical Training Institute

The Glorious Technical Training Institute (GTTI) was initiated in order to provide technical knowhow and add value through imparting training to the young generation which constitutes a major portion of the mass people of Bangladesh. The goal of this institute is to convert them into effective manpower in order to reduction poverty throughout the country. The institute was founded in 2008 as a project under Krishi Foundation.

The Institute has been approved by the Bangladesh Technical Education Board to conduct trade courses of 6 months duration. Presently, the GTTI is located at Goran, Chatbari (on the west side of National Botanical Garden), Section-1, Mirpur, Dhaka 1216. Courses on Welding, Electrical, Auto Mechanics, Driving, Plumbing and Civil Construction are currently being offered as per approval of Bangladesh Technical Education Board. So far, about 2000 students have been trained in 120 courses under six trades. About 50% of the trained students have been self employed, while the others are employed by different companies.





GLORIOUS International School and College

The Krishibid Group has established an international standard educational Institute named Glorious International School and College (GISC). This school is located within the Krishibid City campus at Komolapur of Savar Upazila, about 2 km South-west from Mirpur of Dhaka City. The school follows English medium under British curricula. Besides, emphasis is given on building moral and ethical values among the students. There are both residential and non-residential facilities covering medical and health support, sports and recreation, and moral environment. The school envisions to motivating the students on the inspiration of our great liberation war, patriotism and national unity.



KRISHI Foundation

The Krishi Foundation is a non-profit organization established to carry out the corporate social responsibilities (CSR) of Krishibid Group. The Foundation is also committed to promote agricultural science and technology as well as to assist the underprivileged people of the society through capacity building e.g. providing education, training and employment, income generation, healthcare and medicine. 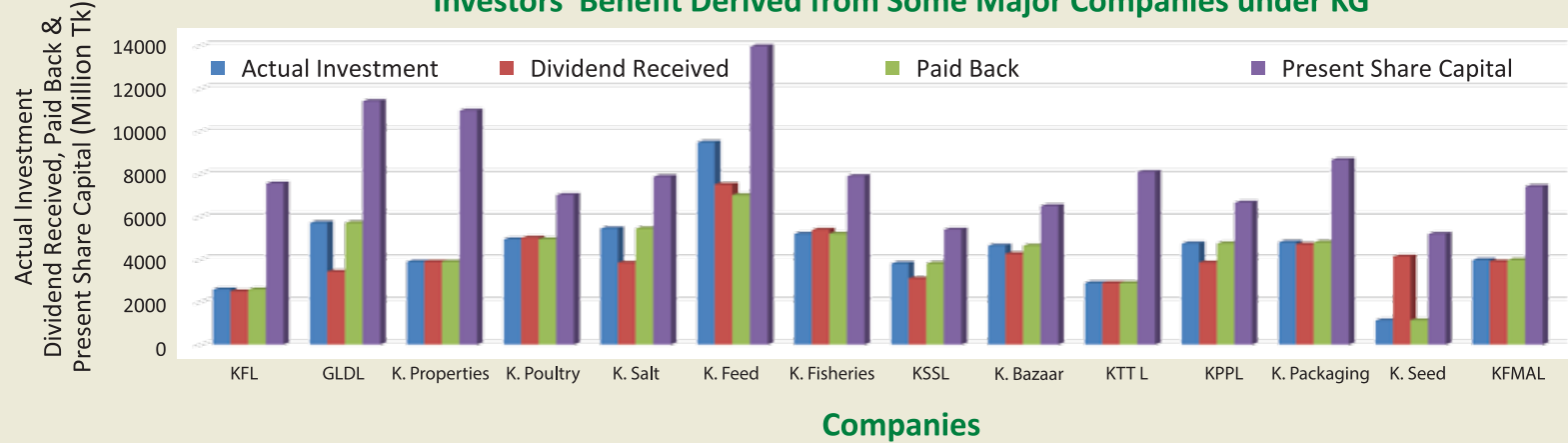
Governance Of The Krishibid Group

Thirty Three sister concerns are being operated under the corporate governance of the KG. A nine-member Board of Directors, elected by the shareholders governs the KFL, the holding company. The policies that are adopted by the board are executed by a six - member Executive Committee (EC). The EC members are usually selected by the KFL board from amongst the MDs/CEOs of different companies. However, the EC Chairman is someone other than from the MDs/CEOs.

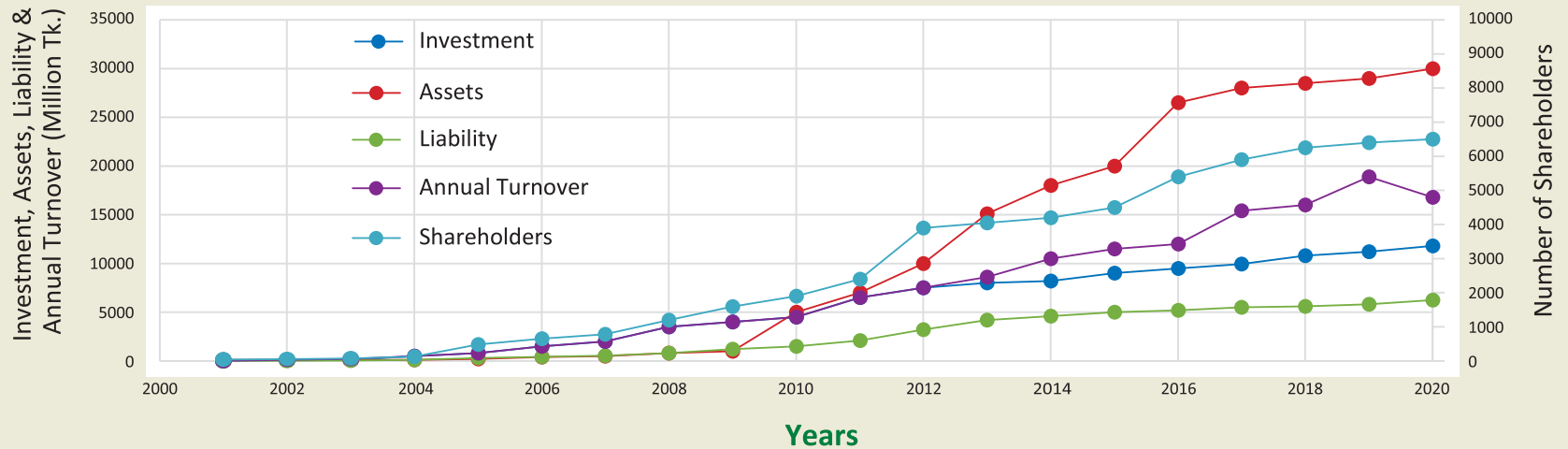
All individual companies are governed by the respective 9-member Board of Directors (BoD). The BoD is initially formed by the KFL which is comprised of three Directors elected by the shareholders and six are nominated from other companies. The Managing Directors of the concerned company are always appointed by the KFL Board. The Chairman and Managing Director of the holding company (KFL) are, respectively the Chairman and Managing Director of the Group, who are currently Prof. Dr. R. I. Sarker and Dr. Md. Ali Afzal.

KG VISION & MISSION 2100

The Krishibid Group envisions to become a recognized world leading business group by the end of 2100 and be the national leader in all agricultural sectors of Bangladesh. The group will play an important role in the agricultural development of Bangladesh having substantial contribution to the country's GDP. By the end of 2100 KG Assets will be Tk. 500 Trillion. We hope to achieve the Vision through implementation of the following six program areas:

1. Food and Agriculture Program

Bangladesh is a country of about 165.57 million people which will grow to some 250 million by 2050 and 350 million by 2100. With a mission of ensuring supply of safe food for this huge population, the group will establish all forward and backward linkage industries in the three major sub sectors of agriculture i.e. crop, livestock and fisheries. We will capture a market share of at least 30% by 2100.

2. Service Sector Program

By the end of 21 century, the KG will expand production and distribution of essential consumer goods particularly safe agricultural products up-to Upazila level. Online marketing network will be extended nationwide and also over the globe. KG will sale safe and organic products with a market share of over 25%. Other services like composite printing solution and packaging solution, tourism services of all kinds etc. will be ensured. 5-star global chain hotels will be established at least in ten locations of Bangladesh and overseas countries.

A 100 storied Krishibid Tower, 10 eco-friendly high tech industrial parks along with financial organizations including Banks & Insurance companies will be established. Krishibid Trade Centers (KTC) will be erected in all big cities.

3. House Building Program

To make a significant contribution in solving the residential problems of the ever-growing population, particularly those of the agriculturists and farming community, the group will build modern residence for at least 10 million people using High Tech and at reasonable cost in all the big cities and districts. The apartments shall be provided with standard and modern facilities.

4. Education Program

With a goal of building patriot and good citizens, education system will be remodeled. The Krishibid Group will establish at least 50 universities in big cities. KG will make our huge population into assets through 500 technical and vocational education institutes and will export skilled manpower to Global Market.

5. Health Program

The KG will establish world class medical college and chain hospitals in 50 cities. International standard pharmaceutical industries will also be established with a target of capturing 10% market share in the sector.

6. CSR Program

The KG assumes it to be her responsibility to support the underprivileged people of the society. It will therefore, undertake mass social welfare program to assist these people. With this end in view, the group will allocate 5% of her annual profit. However, all assistance to the needy people will be provided in kinds e.g. health, education, farm inputs etc. KG - CSR will be carried out through Krishi Foundation & KIDS for socio-economic developments nationally & internationally.
